Those eligible for nomination include any woman that is a member of the IPTA and is involved in daily activities of a student transportation operation.

#### **Guidelines for Nomination**

- The district that employs this individual must be a member of the IPTA.
- The individual must have a contract or employment agreement with a School District.
- The Holly Hoglund Klein "Iowa Woman in Transportation" Award is presented to a female Transportation Director, Supervisor or <u>any</u> female that has exhibited outstanding leadership and service to her school, community and to the safe transportation of children in Iowa.

### Award Description

• Recognition at the IPTA Annual Conference & Trade Show and a commemorative plaque.

#### Notification

• Notification is by the President of the IPTA Board of Directors no later than June 10<sup>th</sup>, 2023.
